A. Name of Post: Deputy Manager (Electrical) – 40 Posts

Qualification: B.E/B. Tech Degree in Electrical/Electrical & Electronics with at least 60% marks from a recognized University/Institution.

Experience Profile: Minimum 10 years of post-qualification executive experience (including training period, if any) in the power sector (Coal, Gas, Lignite) in Operation/ Maintenance/Commissioning/Erection/ Engineering or combination thereof in the relevant discipline in a power plant/power project of capacity 200 MW or above.

B. Name of Post: Deputy Manager (Mechanical) –70 Posts

Qualification: B.E/B. Tech Degree in Mechanical/Production with at least 60% marks from a recognized University/Institution.

Experience Profile: Minimum 10 years of post-qualification executive experience (including training period, if any) in the power sector (Coal, Gas, Lignite) in Operation/ Maintenance/Commissioning/Erection/ Engineering or combination thereof in the relevant discipline in a power plant/power project of capacity 200 MW or above.

C. Name of Post: Deputy Manager (C&I) – 40 Posts

Qualification: B.E/B. Tech Degree in Electronics/Control & Instrumentation/ Instrumentation with at least 60% marks from a recognized University/Institution.

Experience Profile: Minimum 10 years of post-qualification executive experience (including training period, if any) in the power sector (Coal, Gas, Lignite) in Operation/ Maintenance/Commissioning/Erection/ Engineering or combination thereof in the relevant discipline in a power plant/power project of capacity 200 MW or above.

Out of the above-mentioned 10 years of post-qualification experience (Including training/trainee period, if any) in the executive cadre, they should have minimum 02 years of experience in the pay-scale of Rs 60000-180000 or above (IDA pay scale of E3 grade or above of NTPC effective from 01.01.2017) or equivalent scale.

GENERAL CONDITIONS:

1.

Only Indian Nationals are eligible to apply.
2.

All qualifications should be from Universities / Institutions recognized and approved in India. SC/ST/PwBD candidates with passing marks in the qualifying degree are also eligible to apply for the post.
3.

All computations of age/ experience requirement / qualification etc. shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
4.

The category once filled in the online application form cannot be changed and no benefit of other category will be admissible later. Candidates claiming to belong to a particular category should necessarily have the applicable year's/valid EWS/OBC/SC/ST/Disability certificate, as the case may be, from the Competent Authority (in the latest prescribed format of Govt. of India). Where there is a vacancy identified for such category, upper age limit is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates & by 10 years for PwBD candidates. Relaxation of age to Ex-Serviceman will be as per Govt. guidelines.
5.

Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / increase the number of vacancies, if need arises, without any further notice and without assigning any reason thereof.

In-order to restrict the number of candidates for further selection process, if so required, the management reserves the right to conduct multi-stage selection process which may comprise of application shortlisting/screening (based on qualification/percentage of marks, no. of years of post-qualification experience etc.), written/computer-based test, personal interview etc. or combination of the above or to raise the minimum eligibility standards/ criteria, as per requirement.

It is pertinent to mention that the mere fact that a candidate is fulfilling the minimum eligibility criteria as prescribed in the advertisement would not bestow on him/her the

right to be shortlisted/called for written test/Interview or to be considered further for the selection process.

Posting shall be at any of the Stations/ Projects/ JVs/ Subsidiaries of NTPC. All posts are transferable at the sole discretion of the Management.

While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above, as on the specified dates and that the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. HOW TO APPLY

1.

Interested candidates should log on to our website careers.ntpc.co.in or visit the careers section at www.ntpc.co.in to apply. No other means/ mode of application shall be accepted. Candidates are required to possess a valid email ID. NTPC will not be responsible for bouncing back any email sent to the candidates.
2.

Candidate belonging to General/EWS/OBC category is required to pay a non-refundable application fee of Rs. 300/-. **The SC/ST/PwBD/XSM category & female candidates need not pay the application fee.**
Payment in offline mode: State Bank of India has been authorized to collect the application fee, in a specially opened account (A/C No. **30987919993**) at CAG branch, New Delhi (Code: 09996), on behalf of NTPC. Candidate has to approach the nearby SBI branch with a printout of the “pay-in-slip” which is available on the application portal. The pay-in-slip printed from the portal should only be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the bank will issue a unique Journal Number and a Branch Code of the bank collecting the money. This journal number and the branch code are to be filled up by the candidate during an online application. NTPC will not be responsible, in case a candidate deposits the fee in the wrong account.
Payment in online mode: Candidates also have the option to pay the fees online (through Net banking / Debit Card / Credit Card). The online payment option will be available in the online application form.
3.

Fees once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility criteria before paying the application fee.

After applying online, the candidate is required to download the application slip generated by the system with unique application number. Copy of application slip may be retained by the candidate for future reference. No document is required to be sent to us by post.

All experience related documents for one organization/company need to be placed together in a chronological order, starting from the first to the last/current company.
