# **Company Profile:**

THDC India Limited is a leading Power Sector and Profit-making Public sector Enterprise and registered as a Public Limited Company in July-1988 under the Companies Act, 1956. THDCIL was conferred "Mini Ratna' Category- Status in Oct-2009 and up-graded to Schedule 'A' PSU in July-2010 by the Govt. of India.

The Equity of Company was earlier shared between Govt. of India and GoUP in the ratio of 75:25. Pursuant to Strategic Sale, the Share Purchase Agreement was executed between NTPC Limited and President of India on 25th March 2020, for acquisition of legal and beneficial ownership of equity held by the President of India in THDC India Limited. After Strategic Sale, Equity in THDC India Limited is shared between NTPC Limited and Government of UP in a ratio of 74.496% and 25.504%.

The Authorized Share Capital of the Company is 4000 Cr and paid-up capital as in Sep-2024 is 3665.88 Cr. Net Worth of the THDCIL as of 31th March 2024 is Rs 10546.68 Cr. THDCIL started earning profits from first year (2006-07) of commercial operation of its maiden project i.e. Tehri HPP (1000 MW) and is consistently profit-making company since then.

THDCIL was constituted with the sole objective to develop, operate & maintain the 2400 MW Tehri Hydro Power Complex, and other Hydro projects. However, over time THDCIL has expanded its horizons and fully diversified in all types of conventional and non-conventional forms of energy.

Presently, THDCIL has 06 Nos. Power Plants and 1 Coal Mine under operation with a total generation capacity of 1,587 MW (1424 MW Hydro, 113 MW Wind and 50 MW Solar Power Generation) and 5.6 MTPA. The company has 04 projects under construction with a combined installed capacity of 2775 MW including Tehri PSP (1000 MW), Vishnugad Pipalkoti HEP (444 MW), Khurja STPP (1320 MW), and an 11 MW Floating Solar project at Khurja STPP.

Memorandum of Agreement (MOA) for the implementation of the 1200 MW Kalai-II Hydro Electric Project in the Anjaw District of Arunachal Pradesh was signed between GoAR (Govt. of Arunachal Pradesh) and THDCIL. Transfer of various clearances is in progress Other 03 Hydro Projects.

THDCIL has signed an MOU with Department of Energy, Govt. of Maharashtra (GoM) for harnessing of Pumped Storage Energy through six number of PSPs in Maharashtra, totalling to installed capacity of 6790 MW capacity. DPR preparation work for 2 projects will be awarded in Nov'24.

THDCIL has also signed MoU with MREL, Maharashtra for the development of self-identified PSPs and other RE projects (Total tentative capacity: 4200 MW) in Maharashtra State.

THDCIL signed Memorandum of Understanding (MoU) with Karnataka Power Corporation Limited (KPCL) for development and implementation of 1500 MW Pumped Storage Plant at Varahi in Karnataka State.

Besides, THDCIL has signed MoU with Govt. of Rajasthan for Bisanpura PSP (800 MW) in Bundi District, Rajasthan and Rampura PSP (800 MW) in Tonk District, Rajasthan with intent to establish these projects.

Infrastructure and Industrial Development Commissioner (IIDC), GoUP granted in-principle approval for the development of a PSP with 1200 MW project in Sonbhadra District, Uttar Pradesh.

'TUSCO Ltd.', a joint venture between THDCIL and UPNEDA has been incorporated to develop 2000 MW of Ultra Mega Solar Power Parks. Accordingly, 600 MW Solar Power Park each in Distt Jhansi & Distt. Lalitpur and 800 MW Solar Park in Distt Chitrakoot are being developed.

'TREDCO Rajasthan Ltd.', a joint venture between THDCIL and RRECL (Rajasthan Renewable Energy Corporation Limited) has been incorporated for development of 10,000 MW Ultra Mega Renewable Energy Parks. In principle approval for 2000 MW Bodana Solar Power Park received from MNRE.

THDCIL-UJVNL Energy Company Limited (TUECO Ltd.), a joint venture between THDCIL and UJVN Ltd. has been incorporated for the development of potential HEPs and PSPs in the state of Uttarakhand.

THDCIL is actively pursuing 2 PSPs namely, Rouni PSP (2100 MW) and Dangari PSP (1400 MW) both located in Jashpur District, Chhattisgarh for development through a JV mode.

THDCIL is also in process of implementing a Pilot Project for Carbon capture of 20 TPD capacity at Khurja STPP (2x660MW) with a cost-effective Carbon capture technology.

# **IMPORTANT NOTE:**

- 1. Knowledge of domain subjects in respective engineering disciplines and software skills .i.e Autocad, Rocscience, Phase2, Staad.pro etc.
- 2. All qualification (i.e Xth, XIIth and essential qualification) should be Full-Time & Regular and from an Indian University/Institute recognized by AICTE appropriate statutory authority.

# **RELAXATION & CONCESSION**

## **SELECTION PROCESS**

As per the Scheme for Engagement of Personnel on Fixed Tenure/ Purely Short-Term Basis, where Selection involves only Personal Interview.

# **General Conditions of Empanelment:**

- (i) No candidate securing overall less than 50% marks will be empanelled.
- (ii) For SC/ST/PwBDs/ Ex-Servicemen candidates will be required to secure at least 40% marks for their empanelment. (wherever vacancy is reserved for the respective category)
- (iii) Empanelment will be made in order of merit.

# **REMUNERATION**

- Candidate selected on Fixed Tenure Basis (FTB) as Field Engineer (Level I) shall be paid Fixed remuneration of Rs 53,580 (Rupees Fifty-Three Thousand Five Hundred Eighty only) per month.
- Monthly conveyance reimbursement is payable for using the Vehicle for official purpose on certification basis. The amount of monthly reimbursement shall be Rs 6,620 (Four Wheelers) or Rs 3,140 (Two Wheelers).
- HRA as per the rates applicable at X/Y/Z classification of cities shall be payable on Fixed Remuneration per month, if accommodation is not provided by the company.
- The 12% employer contribution towards EPF shall be in addition to the Fixed remuneration mentioned above. However, the 12% employee contribution towards EPF shall be deducted from Fixed remuneration every month.
- In case of death/disablement while in service, the statutory payment of Gratuity shall be made by the company as per the Payment of Gratuity Act,1972.
- FTBs will not be eligible for any PRP/Incentives.
- Other Remuneration/Benefits as per Scheme for Engagement of Personnel on Fixed Tenure/ Purely Short-Term Basis.

# LEAVES, COMPENSATORY OFF AND EXTRA ORDINARY LEAVE

- 12 Casual Leaves and 02 days Optional Leaves shall be allowed for one-year Contract Period.
- FTBs shall be allowed 15 days Earned Leave in a year of Contract Period and shall be credited on monthly pro-rata basis. Earned Leave to FTBs credit is encashable during or at the end of period of engagement. Further, Earned Leave to FTBs credit can be carried forward at the time of extension of the tenure. The other terms & conditions of Earned Leave shall be as under:
  - (i) Intervening Sundays and Holidays falling within the spell of earned leaves will be counted as earned leave. However, the holidays preceding and/or succeeding the leave period shall not be counted as leave.
  - (ii) Leave encashment shall be provided on the basis of Fixed remuneration. FTBs under suspension will not be eligible for encashment of earned leave. FTBs where service are terminated owing to disciplinary proceedings shall not be eligible for encashment of Earned Leaves.

- Maternity Leaves as per the Maternity Benefit Act, 1961 subject to fulfilling other laid down conditions in the act to the female FTBs.
- Special Additional Leave (SAL): FTBs engaged in Projects/ Plants are eligible for 12/22 SAL (as applicable at the respective Projects/Plants) in a year where he/she is posted. SAL shall be availed within the Contract Period or encashed within one month of the completion of one-year Contract Period, after which it shall lapse. The encashment of SAL, if any, shall be calculated on Fixed Remuneration of the FTBs. This leave shall not be carried forward due to any reason whatsoever.
- FTBs rostered for duties in shifts/relay in the Operation & Maintenance of Power Plant/Mines (engaged on coal production/ OB removal only), for working on Weekly offs/Festival/National holidays (i.e 12 Festival holidays including 3 National Holidays) shall be eligible for compensatory off.
- Extra Ordinary Leave means leave sanctioned under special circumstances without any remuneration when no other kind of leave is due. Quantum of Leave and reason is as below:
  - (i) Illness/ Medical Emergency for self- upto one month on the production of Medical Certificate.
  - (ii) Other Extreme compelling situations- upto 15 days.
- Other terms & conditions related to Leaves, Compensatory Off and Extra Ordinary Leave shall be as per Scheme for Engagement of Personnel on Fixed Tenure/ Purely Short-Term Basis

# **MEDICAL FACILITY**

- **OPD:** Medical facility to self, spouse and two dependent children limited to maximum of one-month Fixed remuneration for OPD per year in total taken together treatment at THDC Dispensaries/ Empanelled / Non-empanelled hospitals. This shall not include additional allowances payable for posting at the notified location/project in the scheme.
- IPD: FTBs inclusive of family (spouse and two dependent children) shall be provided with Medical Insurance in case of IPD treatments during tenure of engagement having sum assurance upto Rs 5 Lakhs per annum.
- Reporting Officer shall be the Competent Authority for the sanction/counter sign of medical reimbursement.

## **INSURANCE**

- **GPAIS Coverage:** FTBs will be covered under Group Personal Accidental Insurance Scheme, for Field Engineer (Level I)- Insurance cover for Group Personal Accidental Insurance Policy is Rs 6 Lakhs with monthly premium of Rs 1140/- payable by the employer.
- Additional Insurance at Non-Family Stations: Further, in addition to the existing GPAIS coverage, an Additional Insurance Coverage shall be applicable for the FTBS posted at Non-Family stations, for Field Engineer (Level I)- the insurance coverage is Rs 15 Lakhs. (The charges for insurance premium shall be borne by THDCIL)

• Employees' Deposit Linked Insurance (EDLI): FTBs will be covered under the Scheme of EDLI under the Employees' Provident Fund & Miscellaneous Provisions Act, 1952 for a maximum sum assurance of Rs 7 Lakhs. The charges for insurance shall be borne by THDCIL.

# **CONDUCT**

The FTBs are required to maintain high standards of Conduct as provided in THDCIL CDA Rules/ Standing Orders. The Conduct/Performance of FTBS shall be duly assessed from time to time.

# TENURE OF ENGAGEMENT AND TERMINATION OF CONTRACT

- FTBs will be engaged temporarily for a period of 1 year which can be extended on the yearly basis for additional 3 years in stages based on the performance, requirement and recommendation of the duly constituted committee to evaluate the performance. Engagement will terminate automatically on completion of tenure, if no further extension is allowed. However, the total period of engagement will be as mentioned in contract or offer of engagement but not to be extended beyond 4 years in any circumstances.
- Services during the tenure of engagement will be purely on temporary basis. Contract is liable to be terminated in case performance or conduct is not found satisfactory.
- The tenure can be terminated by either party by giving one month notice in writing subject to fulfilling terms and conditions of service agreement bond.
- FTBs shall have no vested right to claim for regularization or permanent absorption during the period of engagement and thereafter, on account of rendering service on fixed tenure basis in THDCIL

# **AGREEMENT**

- FTBs shall have enter into Service Agreement with THDCIL as per the prescribed proforma provided in Scheme for Engagement of Personnel on Fixed Tenure/ Purely Short-Term Basis.
- Notwithstanding anything contains herein or in any other rules, regulations, scheme, orders, communication
  issued and being in force from time to time the Service Agreement can be terminated by THDCIL at any
  time without assigning any reason, or if any discrepancy in the information/ document provided by FTBs
  comes to the notice of THDCIL at a later stage.
- The Terms and Conditions of engagement shall clearly mention that THDCIL reserves right to modify, alter, change, add or delete the terms of engagement without any prior notice and the same shall be mandatorily applicable.

# OTHER TERMS AND CONDITIONS

- FTBs will be governed by rules and regulations of THDCIL as applicable from time to time.
- FTBs are liable to be posted at Project Sites/Offices/Units of THDCIL anywhere in India.
- The engagement of FTBs is subject to verification of character and antecedents/ and caste certificates and
  in case of any false claim made, the engagement will be terminated without assigning any further reasons
  and prejudice to such actions as may be taken under the provision of the Bharatiya Nyaya Sanhita/ IPC for
  production of false certificates.
- FTBs shall not be provided the facility of Loans in THDCIL.
- No other Allowance/Benefits/PRP/Incentives will be admissible.
- Unauthorized absence from the duty will be liable for the termination of the contract automatically.
- FTBs shall be allowed to avail the facilities of Transit Camp Accommodation. The charges/rate shall be as applicable as per the rules.
- All the terms and conditions mentioned in Scheme for Engagement of Personnel on Fixed Tenure/ Purely Short-Term Basis amended from time to tine shall be applicable.

# **MEDICAL FITNESS**

No person shall be appointed in the service of the Company unless such person has been certified by a duly qualified and registered medical practitioner or medical board or Chief Medical Officer or Civil Surgeon of a Govt. Hospital as approved by the Company to be medically fit to discharge his duties, except that in case of persons appointed from the Government or Public Enterprises such a certification, at the option of the Company will not be necessary, if he had been earlier medically examined for the previous employment.

- 3. Computation of age shall be done as on 11.06.2025.
