The All-India Institute of Medical Sciences, Rajkot, Gujarat is a Central Autonomous Body (CAB) formed by an Act of the Parliament. The administrative ministry is *Pradhan Mantri Swasthya Suraksha Yojana* division of the Ministry of Health and Family Welfare, Government of India. AIIMS, Rajkot adheres to AIIMS Act, Rules and Regulations available on the website of the PMSSY and also on website www.aiimsrajkot.edu.in. The posts of Faculty (Professor, Additional Professor, Associate Professor and Assistant Professor in various disciplines, are governed by Act, Rules and Regulations of AIIMS, Rajkot. The candidates are expected to apprise themselves of provisions of AIIMS Act, Rules and Regulations before deciding to apply for this position.

2. Reservation will be as per Government of India guidelines issued from time to time.

6. Reservation to SC/ST/OBC/EWS/PwBD will be given as per instructions issued by Department of Training, Government of India from time to time read with the advertisement.
7. Age and all other qualification will be counted as on the last date of submission of application (crucial date).
8. Overseas Citizen of India (OCI) cardholders under section 7(A) of Citizenship Act, 1955 are also eligible to apply for teaching post as per Ministry of Home Affairs Order No. 26011/52/2016- OCI dated 02nd August, 2018.

3. Application Process:

The On- line registration of applications will be on the official website of AIIMS, Rajkot i.e. www.aiimsrajkot.edu.in The notification for date of activation of link for submission of online applications in respect of above said posts along with other relevant information will be subsequently notified on the Institute's website.

- The candidate must ensure that their photo, signature and thumb impression should be clearly visible in preview at the time of online application. If photo/signature/thumb impression image is displayed small or not visible in preview on website, that means photo/signature is not as per the AIIMS, Rajkot prescribed guidelines and in that case, their application can be rejected. So, candidates are advised to be very careful while uploading their photo and signatures. Both must be visible clearly on Online Application Form before final submission.
 - No documents including online application form is required to be sent physically, however, all the applicants are advised to keep a hard copy of online application forms with them along with proof of payment (a copy of online payment receipt) for their records.
- The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing (crucial) date of applications failing which their application will be rejected.

8. Upper Age Limit:

Professor / Additional Professor: Not exceeding 58 (Fifty-Eight) years as on closing date of application (Crucial Date).

10. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/ PwBD will be considered subject to production of Caste Certificate issued by the appropriate/ competent authority on the prescribed format. Community should be clearly and legibly mentioned in the certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidates will not be considered under any of the applied reserved category post(s).

11. Person with Disabilities (PwD) /candidate(s) with benchmark disability will be allowed in accordance with Ministry of Social Justice and Empowerment's, Notification No. 16- 15/2010DD.III dated 29th July, 2013 as amended from time to time, in the above recruitment process. Further, only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability.

12. Persons who want to avail the benefit of reservation would have to submit a Disability Certificate issued by a competent authority in prescribed format.

13. **Qualifications and Experience:** The experience will be counted as on last date of submission of application; The experience is counted after obtaining the qualifying degree/PhD.

14. **Short Listing:** The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection. Based on the format (Annexure 1). The Selection Committee may short-list candidates for interview if the vacancy candidate ratio exceeds 1:6. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview.

a). The candidates may note that the proceedings of the Standing Selection Committee are confidential and under no circumstances the minutes will be disclosed to the participants. Reserve category candidates applying for unreserved posts will be treated as unreserved candidates.

19. The applicants already in Government service shall have to produce NOC at the time of attending the Interview, & Relieving Certificate from their present employer before joining the Institute.

22. SELECTION PROCEDURE:

- a) The Online applications of the candidates will be received scrutinized by the scrutiny committee of the Institute and only the eligible candidates will be called for personal interview before the Standing Selection Committee of the Institute. In case, the numbers of applicants are large, the selection committee of the Institute may short-list candidates on the basis of Objective screening score. (Appendix 1)
- b) Only the eligible candidates/ provisionally eligible candidates will be called for verification of original documents before the interview. However, the eligibility would be provisional subject to fulfilment of all requirements failing which he/she will not be allowed to appear for interview.
- c) Interview dates will be intimated on official website only.



- d) The candidates called for interview would be required to make a presentation on his/her work/achievements before the selection committee for a duration not exceeding 05 minutes. The presentation should be prepared in the MICROSOFT POWER POINT only and should contain information as per the prescribed proforma.
- e) The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- f) The date and time for interview will be intimated to the eligible/ provisionally eligible candidates only and the same will also be published in the AIIMS Rajkot website. The information regarding eligibility of candidates will be published in AIIMS website only.
