POST GRADUATE TEACHER EXAMINATION-2025

The Arunachal Pradesh Public Service Commission invites online application from the citizens of India for admission to **Post Graduate Teacher Examination-2025** for filling up **111 (One Hundred Eleven)** posts of **Post Graduate Teacher (PGT)** under Education Department of Govt. of Arunachal Pradesh in the Pay Matrix Level-08 (₹ 47,600/- to 1,51,100/-), Group -B (Gazetted) as admissible under rule. The subject wise details of vacancy are as below:-

NOTE: The number of vacancies, reservations for APST and PwBD candidates and the eligibility criteria mentioned above are as per "Proforma of Requisition" submitted by the indenting/requisitioning department of Government of Arunachal Pradesh.

(A) HOW TO APPLY

- (1) Before filling the Online Application Form (OAR) for the post advertised, a candidate must mandatorily register for **ONE TIME REGISTRATION (OTR)**.
- (2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- (3) Candidates are required to apply online on APPSC website <https://appsc.gov.in>. Detailed instructions for One Time Registration (OTR) are available on the APPSC website.
- (4) Applicants in Government Service have to upload a copy of intimation submitted to their respective Heads of Department or NOC issued by the department.
- (5) The applicants are advised to submit only single application, however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- (6) The online application submission link shall be active from **1700 hours on 16.08.2025** till last date of submission, that is, before **1300 hours on 08.09.2025** on the APPSC website <https://appsc.gov.in>.
- (7) The candidates should carefully fill the requisite details in the online application form. Any information found to be wrong at any stage of examination may lead to cancellation of candidature for **Post Graduate Teacher Examination-2025**.

(B) ELIGIBILITY

- (1) 2nd Class Master Degree in the concerned subject from a recognized University with B.Ed.
- (2) Candidates who have appeared or are appearing in the final year/semester examination of the Master Degree are also eligible to apply. However, their candidature will finally be accepted on production of proof of having passed the qualifying examination in original on or before the date of interview fixed by the Commission failing which they will not be allowed to appear in the Interview/Viva-Voce.

(C) METHOD OF SELECTION

- (1) The eligible candidate will have to appear in written examination (mains) notified by the Department of Secondary Education, Government of Arunachal Pradesh vide Notification No. DSE-11027/1/2021-DSE-ED dated 31st May, 2025 in the following subjects followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission (APPSC):

Note: Recruitment Test, if conducted, shall be objective type. The syllabus of Recruitment Test and Written Examination (mains) can be downloaded from the APPSC website <https://appsc.gov.in> alongwith relevant notifications.

(C) AGE LIMIT

- (1) ONE TIME RELAXATION on upper age limit for General Category candidates, born on or after 01/01/1989 and the Arunachal Pradesh Scheduled Tribe (APST) candidates born on or after 01/01/1984 will be applied in accordance with the Department of Administrative Reforms, Government of Arunachal Pradesh Notification vide no. AR/219/2022-US-1-AR dated 21st April, 2025.
- (2) Age concession in respect of candidates belonging to PwBD Category and regular Government servant of Government of Arunachal Pradesh will be as per Government rules and regulation in force from time to time.

(E) EXAMINATION DATE

- (1) In case the number of applicants is more than the desired ratio, Recruitment Test will be conducted on 12th October, 2025 (Sunday).
- (2) The Written Examination (Mains) for the Post Graduate Teacher Examination -2025 has been tentatively scheduled on 27th & 28th November, 2025 (irrespective of whether RT is conducted or not).

(F) EXAMINATION CENTRES

- (1) The Recruitment Test of Post Graduate Teacher Examination-2025 will be conducted at the following Examination Centres:-

NOTE: The APPSC reserves the right to allocate or change the examination centres, if required at its discretion. No request for change of centre shall be entertained from the candidate by the APPSC.



(G) SCANNED DOCUMENTS AND INFORMATION TO BE UPLOADED

- (1) Signature of the candidate on white paper with black ink pen (40-50 kb in jpg format).
- (2) Latest/Recent colour passport size photo(40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- (3) Self-Attested photocopy of Mater Degree certificates and Final Year/Semester Marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- (4) Self-attested photocopy of Bachelor of Education (B.Ed) certificate and Final Year/Semester Marksheet issued by recognized University.
- (5) Self-attested photocopy of Matriculation Certificate/Marksheet for proof of age issued by the Board only will be accepted. No other documents relating to age, like horoscope, affidavits, birth extract from municipal corporation, registrar of economics and statistics, service records etc. shall be accepted.
- (6) Self-Attested Photocopy of APST certificate and copy of PRC/Aadhar Card in case of General candidates.
- (7) Person with Benchmark Disability (PwBD) candidates should submit disability certificate issued by the certifying authority as per Section 57 of Rights of Persons with Disabilities Act, 2016, failing which, such candidates will be treated as normal candidate and shall not be entitled for any concession. In the Medical Board, the Specialist of the particular disabilities, for which certificate is sought, must be a member. Otherwise, the Disability Certificate will not be accepted.
- (8) In accordance with the Department of Administrative Reforms, GoAP Notification vide no. AR-28/13 dated 30.07.2014 and Department of Administrative Reforms, GoAP OM vide no. F.No.AR-28/2023/414 dated 08.11.2019, the Government Employees of Government of Arunachal Pradesh with 3 (three) years continuous service in same line or allied cadres seeking relaxation in upper age limit should submit Appointment Order/Promotion Order issued by the concerned department as proof of continuous service.
- (9) Persons with Benchmark Disabilities (PwBD) will be allowed compensatory time of 20 (twenty) minutes per hour of the examination on production of a certificate to the effect that the person concerned has physical limitation to write from the Chief Medical Officer/Civil Surgeon/ Medical Superintendent of a Government Health Care Institution in Appendix-I. Format of Appendix-I is available for download in the APPSC website.

(H) APPLICATION FEE

- (1) Candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidate and ₹ 200/- (Rupees Two Hundred) only for other candidate through online mode only.
- (2) PwD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018.



(I) LAST DATE FOR SUBMISSION OF APPLICATION: 08.09.2025 (1300 Hours)

NOTE:

- (1) The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination/interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (2) Eligible candidates will have to produce the above-mentioned (at Point G) Certificates/Documents and Mark Sheets in original at the time of interview, failing which he/she will not be allowed to appear in the interview.
- (3) The Selection will be provisional and subject to verification of requisite documents/ qualifications by the indenting department.
- (4) In case of PwBD candidates, the selection process will be as per the Rights of Persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time.
