

# Notification for Engagement of Trade/Technician/Graduate Apprentice under the Apprentices Act, 1961 at IOCL (Marketing Division)-Northern Region

"NOTE. The reservation for PwBD as indicated for the Discipline of Graduate Apprentice, Trade Apprentice Data Entry Operator (Fresher & Skill Certificate Holders) shall be applied on horizontal basis, across all categories, as per the Government guidelines. PwBD are not eligible to apply for Discipline Code 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111. A person with specified disability listed in the Schedule appended to the Act but not covered under Section 34(1), if certified by the certifying Officer as a person with disability of 40% or above, shall be allowed concession/relaxation available to PwBD. His/ her candidature will not be considered/adjusted against reservation provided to PwBDs under Section 34(1) of the Act of 2016.

For PwBD (Persons with Benchmark Disability) category, Govt. of India Guidelines shall apply.

The Rights of Persons with Disabilities Act 2016 - Section 2(r) defines "person with benchmark disability" as a person duly certified by the certifying authority with

- not less than 40% of a specified disability where specified disability has not been defined in measurable terms and
- a disability where specified disability has been defined in measurable terms.

The candidates are required to submit a Disability Certificate issued by competent authority as per the Rights of Persons with Disabilities Rules, 2017 failing which their candidature as PwBD candidates will not be considered.

Persons with Benchmark Disabilities must be capable of performing the task assigned to them/take instructions using suitable aids and appliances. Engagement of apprentices belonging to PwBD category will be from categories below

1 PV-Low Vision, Blind

P=Physical; V=Vision; H=Hearing;

2 PH-Hard of hearing, Deaf

PL-Musculoskeletal (OH-OA/OL). Dwarfism, Acid attack victim, Cerebral Palsy, Leprosy cured

OH=Orthopaedic Handicap; OA=One Arm; OL=One Leg

MD-Multiple Disabilities (a combination of above)

Deployment of PwBD with other disabilities, may put such PwBDs at risk, considering ours being a hazardous industry, hence not included

STIPEND Rate of stipend payable to apprentices per month shall be as prescribed under Apprentices Act, 1961/1973, Apprentices Rules 1992/2019 nded from time to time.

For Graduate and Technician Apprentice, the stipend will be paid in two parts, Rs 4500 for Graduate Apprentice and Rs 4000 for Technician Apprentice will be paid by the Board of Apprenticeship Training (BOAT) directly in their bank accounts and the remaining amount by Indian Oil Corporation Ltd. It is essential that the tes have an Aadhaar seeded bank account that is enabled for Direct Benefit Transfer (DBT) for receiving the Government's share of stipend from ROAT

Trade Apprentice would be receiving the stipend in full, from Indian Oil Corporation Limited

However, the above shall be subject to change as per guidelines and advice from Government/ Board of Apprenticeship Training/ National Apprenticeship Promotion Scheme (NAPS) or any such body stipulated by the Act/ Rules for issuing guidelines regarding Apprenticeship, from time to time.

Additionally, candidates should possess Skill Certificate of 'Domestic Data Entry Operator' for training of less than one year issued by an awarding body recognized under National Skill Qualifications Framework or any other authority recognized by the Central Government.
- For all discipline codes: The qualification prescribed shall be from a recognized University/institute as a full-time regular course in relevant disciplines. Qualification acquired through Part-time / Correspondence / Distance Learning mode shall render the candidate NOT ELIGIBLE for the above notified disciplines.
- 16. Wherever CGPA/OGPA or Letter Grade is awarded in the Class XIII/ITI/ Degree /Diploma examinations, its equivalent aggregate percentage of marks must be indicated in the Online Application as per the norms adopted by Board/University/Institute. Candidates will have to furnish certificate from the concerned University/Institute regarding the equivalent aggregate percentage of marks with reference to their CGPA/OGPA or Letter grade at the time of document verification failing which their candidature will not be considered.
- 17. Diploma under recognized Institute/University lateral entry scheme (Class XII/ ITI) admitted in the second year of Diploma course shall also be considered eligible subject to meeting prescribed percentage of marks based on aggregate of all semesters in the diploma course.
- 18. The candidates who have undergone Apprenticeship earlier or pursuing Apprenticeship Training in an Industry as per the Apprenticeship Act, 1961/1973/1992 as amended from time to time or job experience for a period of 1 year or more after attainment of the qualification are NOT
- 19. Candidates applying under NATS who have completed five years as on 30.09.2025 in relevant discipline after acquiring the prescribed qualification as per the last semester/ year marksheet shall NOT BE ELIGIBLE for engagement as apprentices.
- 20. Candidates applying under NAPS who have completed five years as on malification 30.09.2025 in relevant discipline after acquiring the prescribed as per the last semester/ year marksheet shall NOT BE ELIGIBLE for engagement as apprentices.
- 21. In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College/Institute from where the candidate pursued his course along with his Application Form.
- 22. Candidates registered with Local/State Employment Exchange(s)/ Vocational Rehabilitation Center for Person with Benchmark Disability (PwBD) and meeting the prescribed eligibility criteria, are required to apply only through NAPS/ NATS portal, failing which their candidature will not be considered.
- 23. Candidates possessing higher professional qualifications such as B.E or equivalent, MBA or equivalent or MCA / CA/ ICWA, LLB or any such equivalent or pursuing higher qualification and having completed the same on or before joining the apprenticeship training shall NOT be considered eligible. A declaration from the candidate in this regard shall be obtained at the time of joining. Suppression of information regarding possession or pursu higher qualification shall render a candidate ineligible for consideration stage of selection/termination or any time during period of training.
- B. Age: Minimum 18 years and maximum 24 years as on 30.09.2025 (Relaxation of 5 years for SC/ST i.e. up to a max of 29 yrs., 3 years for OBC-NCL i.e.up to a max of 27 yrs., for the posts reserved for them). Candidates belonging to PwBD categories shall be given age relaxation up to 10 years (up to 15 years for SC/ST and up to 13 years for OBC-NCL candidates).

# C. Period of Apprenticeship Training: 12 Months

## D. Selection Methodology:

- Candidates registered on NAPS/NATS portal, and applying against the notification shall be considered for selection. There will be no written Test/
- 2. Merit list of all the candidates who have applied against a respective post in the portal and meeting the eligibility criteria shall be prepared based on the percentage of marks secured in the prescribed qualification for the post. In case of two candidates securing same percentage of marks, the candidate with earlier date of birth (older in age) shall be considered. In case of same date of birth, candidates having a higher percentage marks in matriculation shall be considered.
- Candidates are advised to ensure that they are medically fif as per Indian Oil's pre-engagement medical standard. Candidates are advised to go through the "Guidelines and Criteria for physical Fitness for Pre-Engagement Medical Examination" before they commence the application process. - 4. Candidates successfully qualifying document verification and Pre-engagement medical fitness shall be adjudged suitable for engagement and shall be issued offer of Engagement for Apprenticeship Training.

- 10. The candidature of the applicant would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled.   - d) Candidate should have a bank account seeded to his/her Aadhaar Number and the account to be enabled for DBT. If the same is not available, the candidate is required to visit their bank and get their account both Aadhar seeded and DBT enabled.
  - e) Candidates should check if their bank account is Aadhaar seeded using the following link: https://myaadhaar.uidai.gov.in/
  - f) Candidates should check if their bank account is enabled for Direct Benefit Transfer (DBT) using the following link: https://www.npci.org.in/ and check the status under consumer tab of the link.
    - In case any of the above mentioned in 5 (e) and (f) are not linked/ activated, candidate must approach their respective bank's branch for enabling the same.
  - g) Candidates should submit the details of the active bank account to which their Aadhaar is seeded to the Corporation for release of monthly Stipend.

## Venfication of Documents.
