**Interested and eligible candidates may apply online for the post of Management Trainee in various disciplines, as detailed below. The selection process will comprise a Computer Based Test (CBT), followed by multi-stage interviews and psychometric evaluation, as applicable.**



## 1. DISCIPLINE AND EDUCATIONAL QUALIFICATION

**Note :**

- ❖ **Minimum Qualifying Marks:** The minimum qualifying marks for GENERAL (UR), OBC (Non-Creamy Layer) & Economically Weaker Sections (EWS) category candidates are 65%. For SC, ST and Persons with Disability (PWD) candidates, minimum qualifying marks is 60% after giving relaxation of 5%. In case of CGPA/GPA, conversion in percentage certificate issued by University/Institute shall be attached without fail. However, Mark sheet of the



candidate sharing CGPA to percentage conversion formula is acceptable and same can be uploaded.

- ❖ HLL reserves the right to increase / decrease the number of vacancies or not to fill up the vacancies or cancel the recruitment process, as per its requirement.
- ❖ The posting shall be at HLL/any subsidiaries of HLL as desired by HLL. However, depending upon organisational requirement, the candidates are liable to be transferred within different units of HLL. The appointment to the post carries with it the obligation to serve in any unit / division of HLL / worksites/projects undertaken in any part of India or abroad as the case may be.

## 3. AGE LIMIT

- ❖ **Upper Age Limit:** 27 years as on **01.02.2026**
- ❖ Relaxation in age will be applicable for SC/ST/OBC(NCL)/PwD candidates as per Government of India rules.

## 4. RESERVATION

- i) Government of India directives on reservation shall apply.
- ii) Applicants belonging to EWS category should produce a valid *Income and Asset Certificate* issued by any of the following authorities in the prescribed format. This certificate shall only be accepted as proof of applicant's claim as belonging to EWS, failing which their candidature shall not be considered against reservation under EWS category:-



- ❖ District Magistrate/Additional District Magistrate/ District Collector / Executive Magistrate/ Deputy Commissioner/Additional Deputy Commissioner/ 1st Class Stipendary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Extra Assistant Commissioner
- ❖ Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
- ❖ Revenue Officer not below the rank of Thahsildar and
- ❖ Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

iii) Applicants belonging to SC or ST or OBC (Non Creamy Layer), should produce a valid recent community certificate issued by the Revenue Authority not below the rank of the Thahsildar, failing which their candidature will not be considered against the reserved posts, and for other concessions/relaxations applicable to the categories.

iv) In the case of Persons with Benchmark Disabilities, the degree of disability should be minimum of 40%. The applicant should submit a valid Certificate of disability to this effect in the prescribed format issued by Competent Authority as per the Rights of Persons with Disabilities Rules, 2017.

## 5. SELECTION PROCESS

The selection process comprises of multiple phases / stages: including a Computer Based Test (CBT), Preliminary Interview, Psychometric Assessment, and a Final Interview.

### a. Phase I – Computer Based Test (CBT)

The Computer Based Test (CBT) shall be of 90 Minutes (1 hour 30 minutes) duration comprising of 100 Questions as below

**b. Phase 2 – Multi – stage Interview Assessment**

**Stage 1 – Preliminary Interview:**

Candidates who score qualifying marks in CBT shall be shortlisted for next stage of Preliminary Interview. HLL shall call sufficient number of candidates for preliminary interview so as to get candidates in the minimum ratio of 6 candidates against one post in order of merit/reservation

**Stage – 2: Psychometric Analysis**

Candidates shortlisted in Stage 1 Interview will undergo an online psychometric evaluation in the ratio of 1:3. The evaluation will be used as assessment tool to gauge candidates' behavioral attributes, personality orientation, and managerial potential.

**Stage – 3: Document Verification & Final Interview**

Candidates who fail to produce the certificate and testimonials in original shall not be permitted to appear in the final interview. Further to the document verification, the Final interview with eligible candidates in the ratio of 1:3 as decided by HLL.

**6. FINAL SELECTION**

Based on the marks obtained in the final interview and the organizational requirement, the candidates will be shortlisted for appointment as Management Trainee in HLL. The final merit list will be prepared separately for UR/SC/ST/OBC (NCL)/PWD/EWS categories, based on the total number of available vacancies.

**7. COMPENSATION / PAY**

Selected candidates will be placed as Management Trainee on a monthly stipend equal to Basic Pay + DA as applicable to Executives in the level of Deputy Manager (E1 level), ie, Basic Pay Rs.40,000/- per month + applicable DA thereon. On successful and satisfactory completion of 1-year training period and passing the test conducted for the purpose, regularization will be in **Deputy Manager (E-1 Grade)** in the scale of pay of Rs.40,000/- – 1,40,000/-

**8. APPLICATION FEE**

Candidates belonging to **GENERAL (UR) / OBC (Creamy Layer & Non-Creamy Layer) / EWS** categories are required to pay a **non-refundable application fee of ₹1,000/- (Rupees One Thousand Only)** plus applicable **GST**. **SC / ST / PwD** candidates are **exempted** from payment of the application fee. The fee shall be paid **online only**; no other mode of payment will be accepted. HLL Lifecare Limited shall not be responsible for any fee deposited into an incorrect account.



The application fee, once paid, **shall not be refunded or adjusted** against any future recruitment process under any circumstances. Candidates are therefore advised to **carefully verify their eligibility** before submitting the application.

## **9. SERVICE BOND**

Selected candidates shall be required to serve the Company for a **minimum period of 60 months** from the date of joining. Accordingly, they will be required to **execute a Service Agreement Bond for an amount of ₹3,00,000/- (Rupees Three Lakhs only)** at the time of joining.

## **10. TRAVEL ALLOWANCE**

No travelling allowance shall be paid to candidates for appearing in the Computer Based Test (CBT); however, candidates called for document verification and the final interview shall be reimbursed **to-and-fro Third AC rail fare**, as admissible for the post and as per Company rules, by the shortest route from the mailing address mentioned in the online application form to **HLL, Thiruvananthapuram**, subject to production of valid proof. Candidates claiming reimbursement must submit a copy of the front page of their savings bank passbook indicating the account number and IFSC code at the time of document verification, and the eligible amount shall be credited directly to their bank account. Reimbursement shall be made only to those candidates who submit the requisite details. If, during document verification, a candidate is found not fulfilling any of the prescribed eligibility criteria, he/she shall neither be permitted to attend the final interview nor be entitled to any travelling allowance.

## **11. TRAINING FOR MANAGEMENT TRAINEES**

Selected candidates will undergo a **structured Management Trainee Programme** encompassing **classroom-based learning, leadership development camps, and comprehensive on-the-job training** across various units and divisions of HLL Lifecare Limited.

**Step 1:** Enter contact details for First Step registration. SMS with login details will be received.

**Step 2:** Complete the First step by filling demographic detail and select the post applying.

**Step 3:** Enter Education Details/Work Experience

**Step 4:** Upload Photo (.jpeg less than 100KB), Signature (.jpeg less than 100KB), and all relevant Certificate's scanned Images (.jpeg less than 100KB or .PDF less than 10MB).

**Step 5:** Application Preview or Modify

**Step 6: Payment Online Mode** (via credit card, Debit card, net banking, UPI etc.)

A) General/EWS/OBC Candidates - Rs.1180/- (Rupees One Thousand and One hundred Eighty only)

B) SC/ST Candidates – Exempted.

C) Persons with Disabilities - Exempted.

**Note: In case of candidate not fulfilling eligibility criteria (age / qualification) at any stage, application form will be cancelled, and no query will be entertained.**



## 14. GENERAL CONDITIONS

- i. Before applying, candidates must ensure that they meet all the eligibility criteria specified in the advertisement.
- ii. Only online applications submitted through the prescribed website shall be considered for the selection process, and no separate communication will be issued in this regard.
- iii. **All information furnished in the application shall be verified against original documents** at the time of the interview. If any information provided by a candidate is found to be **false, incorrect, or not in conformity with the prescribed eligibility criteria**, his/her candidature shall be **liable for rejection or cancellation at any stage** of the recruitment process.
- iv. Only Indian Nationals are eligible to apply.
- v. SC/ST/OBC/PwD candidates will be eligible for relaxation as per Government of India directives.
- vi. SC/ST candidates must submit a valid SC/ST Caste Certificate in the prescribed format applicable for appointment to posts under the Government of India.
- vii. OBC candidates must submit a valid Other Backward Class (Non-Creamy Layer) certificate in the prescribed format applicable for appointment to posts under the Government of India.
- viii. The crucial date for determining the age limit shall be the same as the cut-off date prescribed for calculating the qualification and post-qualification experience of the candidates.
- ix. HLL Lifecare Limited reserves the right to cancel, restrict, modify, or amend the selection process, or to not fill any or all of the notified posts, at its sole discretion. The number of vacancies may also be increased or decreased in accordance with organizational requirements.
