1. TENURE OF ENGAGEMENT: The tenure of engagement shall be for a period of up to 15 years or the date of Superannuation (60 years) whichever is earlier. However, the tenure of engagement shall be reviewed for extension solely based on individual performance and company requirements on completion of every 5 years.

2. PAY SCALE & ALLOWANCES: Selected candidates will be inducted in E-I Grade, at Pay Scale of Rs. 30,000-3%-120,000/-. In addition to Basic Pay, other allowance like Dearness Allowance, House Rent Allowance, Perquisites at the rate of 35% of the annual basic pay, reimbursement of medical expenses, Group Insurance, PF, Gratuity etc. as per Company Rules will be a part of remuneration package. All emoluments put together, the CTC will be approximately around Rs.8,50,000/- per annum. TA/DA for outstation duty will be given as per Company Rules.

3. UPPER AGE LIMIT:

- a) The candidate should not be more than 50 years of age as on 01.02.2026.
- b) The Upper age limit specified is applicable to UR category. OBC (NCL) / SC / ST / EWS Candidates will be considered on par with UR criteria.
- c) For candidates belonging to PwBD category having minimum 40% disability, age relaxation will be as per prevailing rules.
- d) The Cut-off date for deciding the maximum permissible age and experience (Post Qualification Experience) shall be 01.02.2026.

4. EDUCATIONAL QUALIFICATION & EXPERIENCE: Ex-Servicemen retired / serving officers retiring shortly with Degree in any discipline with PASS CLASS and should be in the rank of Jr. Commissioned Officer (JCO) or equivalent with a minimum 15 years of post-qualification (Professional) experience in the Indian Army/ Air Force/ Navy or Central Paramilitary organizations.

4.1 Retired Candidates who are applying for the post should have been discharged on or after 01.02.2021.

5. JOB RESPONSIBILITIES: The selected candidate will be responsible for coordinating all activities related to management & operations of various facilities in BEL Hyderabad Unit / CRL Ghaziabad Unit. He/she shall monitor, supervise and effectively manage the infrastructure & operational requirements of Canteen, Learning Centre, Guest House, CSR Projects and various other Contractual requirements of the Units. In addition, he/she shall be responsible for carrying out Public Relations activities, hosting/conducting various events / functions, liaise with various agencies, etc. Apart from the above responsibilities, the company reserves the right to add more responsibilities as per the requirement of the company.

6. METHOD OF SELECTION:

- a) Selection will be through Written Test followed by Interview for candidates who have been shortlisted in the Written Test in the ratio of 1:5 in the order of merit.
- b) Written Test will consist of objective type questions for 85 marks from General Awareness and Trade Aptitude.
- c) All candidates shall secure 35% as qualifying marks and PwBD candidates shall secure 30% as qualifying marks in Written Test. OBC (NCL) / SC / ST / EWS Candidates will be considered on par with UR criteria.
- d) The date of the selections, timings and venue will be intimated to the shortlisted candidates through E-mail only.

- g) 'No Objection Certificate' if employed in PSU / Government / Quasi Government and Public Sector undertakings.

There will be no separate communication to any candidates on their non-consideration at any stage of the selection process.

8.1 Only Indian nationals need to apply.

8.2 Candidates employed in Govt./ Quasi-Govt. Organizations and Public Sector Undertaking are required to submit the application through proper channel or produce 'No Objection Certificate' along with the application without which such candidate will not be considered for the selection process.

8.3 BEL reserves the right to change (cancel / modify / add) any of the criteria, method of selection, number of posts; indicated above based on the actual requirement at the time of selection.

8.4 Candidates are required to provide their valid E-mail ID which shall be entered in the application form. Information pertaining to the Written test / Interview will be sent to the shortlisted candidates only by E-mail. No change in the E-mail ID will be allowed. 8.5 Appointment of the provisionally selected candidate will be subject to being found 'Medically Fit' by the Company's medical authorities as per the medical fitness standards laid down by the Company. The candidate who is called to report on selection should get himself/herself medically examined by a Civil Surgeon/Asst. Civil Surgeon and submit the medical report as per the requirement of the Company.

8.6 The admission at all/any stage of selection process will be purely provisional. Mere attending written test and Interview will not imply that his/her candidature has been cleared by BEL. BEL reserves the right to debar / disqualify any candidates at any stage of the selection process for any reason whatsoever.

8.7 Please ensure that the applicant fulfills all the eligibility criteria as stipulated in the advertisement. In case applicant fails to meet any of the eligibility criteria as stated in the advertisement for the post, his/her candidature will be cancelled at any point of selection process. The decision of the management in this regard would be final.

8.8 Short listing of candidates will be carried out purely based on the information declared by the candidates in the application form.
