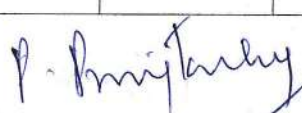

TRAINED GRADUATE TEACHER EXAMINATION (SECONDARY LEVEL)

The Arunachal Pradesh Public Service Commission invites online application from the citizens of India for admission to Trained Graduate Teacher Examination- 2026 (year) for filling up 389 (Three Hundred Eighty-Nine) posts of **Trained Graduate Teacher (TGT)** under **Education Department** of Govt. of Arunachal Pradesh in the **Pay Matrix Level-7 (₹44900-1,42,400/-)**, **Group-B (Non-Gazetted)** as admissible under rule. The subject wise details of vacancy are as below: -

NOTE: The number of vacancies, reservations for APST and PwBD candidates and the eligibility criteria mentioned above are as per "Proforma of Requisition" submitted by the indenting/requisitioning department of Government of Arunachal Pradesh.

(A) HOW TO APPLY

- 1) Before filling the Online Application Form (OAF) for the post advertised, a candidate must mandatorily register for **ONE TIME REGISTRATION (OTR)**.
- 2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- 3) Candidates are required to apply online on APPSC website <https://appsc.gov.in>. Detailed instructions for One Time Registration (OTR) are available on the APPSC website.
- 4) The applicants are advised to submit only single application, however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- 5) The online application submission link shall be active from **1700 hours on 26th March 2026** till last date of submission, that is, before **1300 hours on 27th April 2026** on the APPSC website <https://appsc.gov.in>.

- 6) The candidates should carefully fill the requisite details in the online application form. Their admission at all stages of examination i.e. Written Examination and Viva-voce will be purely provisional. Any information found to be wrong at any time before or after any stage of examination may lead to cancellation of candidature for Trained Graduate Teacher (Secondary) Examination- 2026.

(B) ELIGIBILITY

- 1) The candidate should be a graduate with a minimum Second-Class Bachelor's Degree in Arts, Science or Commerce from a recognized university and must have studied the concerned subject in all years/semesters of the Bachelor's Degree programme. The final year/final semester marksheet of Bachelor's Degree must contain the name and marks of the concerned subject.
- 2) Graduation in any other subject with Post Graduation in the concerned subject shall not be considered eligible for the particular post.
- 3) Candidate should possess a B.Ed (General) degree issued by NCTE recognized institute. Only General B.Ed is acceptable for teaching Classes IX-XII as per letter vide no. DSE-11027/1/2021-DSE-ED dated 09/12/2025.
- 4) B.Ed (Special Education) is not recognized as an alternative professional qualification for TGT(Secondary) as per letter vide no. DSE-11027/1/2021-DSE-ED dated 09/12/2025.
- 5) The minimum duration of B.Ed programme is two years, including mandatory internship in schools. However, for candidates who were awarded the degree before 2015, the course duration of one year will also be eligible.
- 6) Candidates who have completed a Four-Year Integrated Degree Programme with B.Ed (General) included are also eligible subject to fulfilment of subject specific requirements as mentioned in B(1).
- 7) Students in their final year/final semester of Bachelor's Degree/B.Ed are not eligible to apply for the examination.
- 8) Each candidate is permitted to apply for only one TGT (Secondary) post.

(C) METHOD OF SELECTION

- 1) The eligible candidate will have to appear in Written Examination (Objective) as notified by the Department of Secondary Education, Government of Arunachal Pradesh vide Notification No. DSE-11027/1/2021-DSE-ED dated 31st May, 2025 in the following subjects followed by Viva- Voce to be conducted by the Arunachal Pradesh Public Service Commission (APPSC):

- 2) The candidate should note that there will be penalty negative marking of 1/6th for each wrong answer marked by a candidate.
- 3) The number of candidates to be invited for Interview/Viva-voce shall be about three (03) times the number of advertised vacancies (category/ post as applicable) depending on the availability of qualified candidates or as decided accordingly by the Commission subject to securing minimum qualifying marks.
- 4) In order to qualify for viva-voce/interview, the candidate should score an aggregate of 33% of the total marks in both the papers combined, subject to the condition that the candidate should score at least 20% in each of the subject/paper.
- 5) In order for a candidate of PwBD category to qualify for viva-voce/interview, the candidate should score an aggregate of 20% of the total marks in both the papers, subject to the condition that the candidate should score at least 10% in each individual subject/paper.

(D) AGE LIMIT

1. A candidates should not be less than 21 years and not more than 35 years of age as on last date of receipt of Application form i.e. **27/04/2026**. However, the upper age limit is relaxable in accordance with orders issued by the Govt. of Arunachal Pradesh from time to time.
2. One time relaxation on upper age limit for General Category candidates, born on or after 01/01/1989 and the Arunachal Pradesh Scheduled Tribe (APST) candidates born on or after 01/01/1984 will be applied in accordance with the Department of Administrative Reforms, Government of Arunachal Pradesh Notification vide no. AR/219/2022-US-1-AR dated 21st April, 2025.
3. Age concession in respect of candidates belonging to PwBD category and regular Government servant of Government of Arunachal Pradesh will be as per Government rules and guidelines in force from time to time.
4. The date of birth accepted by the Commission will be that which is entered in the Matriculation Certificate issued by recognized Board. No other documents relating to age like horoscope, affidavits, birth extract from Municipal Corporation, registrar of economics and statistics and service records shall be accepted.

(E) EXAMINATION DATE

The written Examination for the Trained Graduate Teacher Examination-2026 has been tentatively scheduled on 12th July, 2026 (Sunday).

(F) EXAMINATION CENTRES

- 1) The Written Examination (Objective) of Trained Graduate Teacher Examination-2026 will be conducted at the following Examination Centres:

Note: The APPSC reserves the right to allocate or change the examination centres, if required at its discretion. No request for change of centre shall be entertained from the candidate by the APPSC.

(G) SCANNED DOCUMENTS AND INFORMATION TO BE UPLOADED

- 1) Signature of the candidate on white paper with black ink pen (40-50 kb in jpg format).
- 2) Latest/Recent colour passport size photo (40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- 3) Self-attested photocopy of the photo id, viz. Aadhar Card/Voter Id/PAN Card/Passport/Driving License/any other photo id card issued by the State/Central Government whose details have been provided in the online application form. This photo ID will be used for all future references and the candidates are advised to carry this ID while appearing for the examination.
- 4) Person with Benchmark Disability (PwBD) candidates should submit disability certificate issued by the certifying authority as per Section 57 of Rights of Persons with Disabilities Act, 2016, failing which such candidates shall not claim the reservation under PwBD category and shall not be entitled for any concession. In the Medical Board, the Speciality of the particular disabilities, for which certificate is sought, must be a member. Otherwise, the Disability Certificate will not be accepted for claiming reservation under PwBD category.
- 5) The date of issuance of Disability Certificate should be before the last date of the online application form submission, that is, **27th April, 2026**.
- 6) Persons with Benchmark Disabilities (PwBD) will be allowed compensatory time of 20 (twenty) minutes per hour of the examination on production of a certificate to the effect that the person concerned has physical limitation to write from the Chief Medical Officer/Civil Surgeon/ Medical Superintendent of a Government Health Care Institution in Appendix-I. Format of Appendix-I is available for download in the APPSC website.

(H) Candidates who clear the Written Examination (Objective) will be required to submit a Detailed Application Form (DAF) in the APPSC portal along with the following documents:

- 1) Self-Attested photocopy of Bachelor's Degree certificates and Final Year/Semester Marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- 2) Self-attested photocopy of Bachelor of Education (B.Ed) certificate and Final Year/Semester Marksheet issued by NCTE recognized University.
- 3) Self-attested photocopy of Matriculation Certificate/Marksheet for proof of age issued by the Board only will be accepted. No other documents relating to age, like horoscope, affidavits, birth extract from municipal corporation, registrar of economics and statistics, service records etc. shall be accepted.
- 4) Self-Attested Photocopy of APST certificate and copy of PRC/Aadhar Card in case of General candidates.
- 5) Intimation letter to HoD, for those who are in regular government service.

- 6) The Government Employees of Government of Arunachal Pradesh with 3 (three) years continuous service in same line or allied cadres seeking relaxation in upper age limit should submit their first Appointment Order/Promotion Order issued by the concerned department as proof of continuous regular service of 3(three) years.
- 7) Any other documents, as maybe relevant.

Any information contained in the attached certificates shall not be considered unless it is claimed in the detailed application form.

Following the Written Examination, the verification of documents for candidates who have cleared the Written examination will be conducted. The candidates will have to produce in person, original and photo copies of the above-mentioned Certificates/ Documents, as well as the Admit Card and a hard copy print out of the detailed application form, at the time of verification of documents. Failure to do so will result in summary rejection of candidature for the Viva-Voce stage. Candidates should duly note that no additional time shall be given for production of documents.

The preliminary determination of the eligibility of educational qualification of candidates for the post for which he/she has applied for, will be made after the verification of documents submitted by the candidates.

(I) APPLICATION FEE

- 1) Candidates are required to pay fee of 150/- (Rupees One Hundred Fifty) only for APST candidate and 200/- (Rupees Two Hundred) only for other candidate through online mode only.
- 2) PwD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018.

(J) LAST DATE FOR SUBMISSION OF APPLICATION: 27th April, 2026 (1300 Hours)

NOTE:

- 1) The candidate should satisfy his/her eligibility before applying and shall be personally responsible in case he/she is not eligible to apply as per the given eligibility criteria. It is to be noted that if a candidate has been allowed to appear in the Written Examination, it does not imply that the candidate's eligibility has been verified. It does not vest any right with the candidate to appear for the Viva-Voce, if selected, or for appointment.
- 2) Candidates will be shortlisted for further stages of examination based on information provided by him/her. Therefore, it will be the sole responsibility of candidate to prove his/her eligibility with respect to qualification criteria advertised by the Commission.
- 3) The Commission may take up the verification of eligibility of the candidate at any stage of the examination. Even if Admit card is issued to a candidate due to lack of information in the application form or otherwise and if it is found at any stage that the candidate is not eligible, then his/her candidature can be summarily rejected.
- 4) Candidate, if found not eligible during the verification prior to the interview shall not be allowed to appear in the interview.
- 5) Candidates falling under the Persons with Benchmark Disability (PwBD) category must ensure compliance with the functional requirements prescribed for the post(s) for which they intend to apply.

- 6) The candidature of the candidate at any stage of the examination is provisional and subject to the outcome of any direction/decision/order/pronouncement of any Court of Law and mere issue of Admit Card or appearance at the examination does not entitle him/her to any claim for the post.
- 7) The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination/interview or selection will be final and no correspondence or personal enquiry will be entertained.
- 8) The candidate must note that the Appointing Authority, that is, the indenting/ Requisitioning Department conducts the medical test and verifies the character and antecedents of the candidates, authenticity of documents/certificates, disability certificates and eligibility as per the Recruitment Rules before finally, appointing the candidates. Therefore, the provisional recommendation of a candidate does not confer upon him/her any right to appointment unless the Appointing Authority is satisfied, after such inquiry as maybe considered necessary, that the candidate is suitable for appointment to the post.
- 9) In case of PwBD candidates, the selection process will be as per the Rights of Persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time
