- Knowledge of security concepts such as cyber-attacks and techniques, threat vectors, threat hunting, threat intelligence, network analysis, risk management, incident management is desirable.

2) Networking:

- Experience in IT networking operations. Hands on experience in Open Sourcetools as well as Commercial tools.

- Security & SOC Operations: Monitor and triage security alerts (SIEM), validate true/false positives, execute initial Incident Response (containment/remediation), and perform Vulnerability Scanning.
- Network Operations: Configure, install, and manage core network hardware (Routers, Switches, Firewalls, Load Balancers). Implement LAN/WAN/VPN networks and ensure performance monitoring/tuning
- Network Security: Implement network security measures, including managing Firewall rules, ACLs, and IPS, in collaboration with security teams
- Vulnerability Assessment & Testing (VAPT): Conduct automated/manual Vulnerability Scans and Penetration Testing (PT) (Black/Grey/White Box) to simulate attacks. Report findings with CVSS scoring and provide remediation strategies.
- Documentation: Maintain up-to-date documentation, network diagrams, and configuration standards

- Performing threat modelling and continuously monitoring network traffic, bandwidth utilisation & device status for security threats.

Note: Teaching/Academic/Research work will not be considered as relevant post qualification industrial experience. experience in banking and financial institutions, non-profit organizations and, internship placements which are a part of academic curriculum will not be considered as experience.

3.0 The upper age limit indicated is for candidates belonging to General & EWS Category. The upper age limit will be relaxed by 3 years for OBC (NCL) candidates, 5 years for SC/ST and 10 years for PwBD candidates (having minimum 40% disability, in addition to the relaxation applicable to OBC (NCL)/SC/ST candidates).

4.0 Period of contract:

For FOE period of contract is for Four Years from the date of joining.

For Project Engineers initially for a period of Three (3) Years from the date of joining. However, the same may be extended upto a maximum of One more year (Maximum tenure of 4 years including the initial period) depending on the progress of the project and performance of the candidate.

5.0 Remuneration:

Field Operation Engineer (FOE): An all-inclusive consolidated remuneration of Rs.60,000/- per month for the 1st Year of engagement, and an increase of Rs.5000/- for every year of extension of contract.

Project Engineer- I: An all-inclusive consolidated remuneration of Rs. 40,000/- per month for the 1st Year of engagement and an increase of Rs.5000/- for every year of extension of contract.

In addition to the above, Consolidated amount of Rs 12,000/- per year will be paid towards insurance premium, attire allowance, stitching charges, footwear allowance, etc. will be paid.

SELECTION PROCEDURE:

- Selection will be through a Written Test for shortlisted candidates, followed by an Interview, only for those candidates who qualify in the Written Test. **The venue for the Written Test will be Bengaluru & Delhi and Venue for Interview will be in Bengaluru.**
- 85% Marks will be allotted for the written test and 15% Marks for the interview. Candidates who pass the written test will be called for interview in the ratio of 1:5 in the order of merit in each role in each category.
- The minimum qualifying marks for General/OBC/EWS candidates is 35% and 30% for SC/ST/PwBD candidates in both written test and interview separately.
