### 3. PAY & OTHER BENEFITS:

The consolidated pay against each post is mentioned in the above table (Clause.2). In addition to the same, the following benefits will be provided.

#### I. **Allowances (Other than Consolidated Pay):**

- Contract employees posted at site/project locations shall be paid Site Allowance @ 7.5% of pay.
- Contract employees posted at Metro Locations shall be paid Metro Allowance @2.5% of Pay.

#### II. **Annual Increment :**

The annual increment shall be 3% of the consolidated pay (rounded to next ten rupees) and shall be further regulated as per rules of the company.

#### III. **Medical Facilities :**

- Medical facilities (OPD, IPD including medicine from Ispat Hospital) shall be provided for self, Spouse and 2 dependent Children as available at Ispat Hospital, if posted at Ranchi.
- For other locations, free consultation facility will be provided by the company's Retainer doctor.
- Reimbursement of annual premium amount paid limited to Rs.15,000/- towards Mediclaim policy (Rs.4,00,000/- on floater basis )as per the company policy.

IV. **Accommodation**

Company's residential accommodation (Family accommodation/Bachelor accommodation of the Company or client) shall be provided depending upon availability, on charges as per prevailing rules of the company. In case, Company's residential accommodation is not availed, HRA at the rate of 5% of consolidated pay shall be paid.

V. **Leave And Holiday**

- Casual Leave (CL) - 12 days in a calendar year on pro-rata basis (1 day per month) shall be provided.
- Earned Leave (EL) - 18 days in a calendar year on pro-rata basis i.e., 1 day for every 20 days worked. EL can be accumulated upto a maximum limit of 45 days.
- Half Pay Leave (HPL) - 14 days in a calendar year on pro-rata with facility of commutation on production of medical certificate.
- Maternity Leave- It shall be as applicable to the Regular Employees.
- National Holidays, Festival Holidays & Restricted Holidays (4 nos.) shall be as applicable to regular employees.

VI. **Group Personal Accident Policy – 25 Lakhs (Sum Insured)**

**4. MODE OF QUALIFICATION:**

- I. The Requisite educational qualification for Engineering should be acquired through Regular/Full Time Course only. For all other posts (Except for Certificate courses and Post Codes: 57,58 &59), it should be acquired through Regular/ Full Time/Open and Distance Learning mode. The certificate courses can be acquired through part time.
- II. The required educational qualifications must have been acquired from Universities / Institutes recognized by Government/ accredited by councils / bodies like UGC /AICTE / MCI / ICAI / ICSI set up by Central or State Government for the purpose.
- III. In case of any dispute arising about admissibility of any particular qualification the decision of Chairman & Managing Director, MECON Limited shall be final and binding.

**5. DEFINITION OF WORK EXPERIENCE:**

1. The work experience shall be in full time job on regular salary basis and in relevant area as stipulated against respective posts.
2. In case of intermittent nature of job the actual days engaged in full time job only will be considered for calculating number of years of experience.
3. Any other nature of experience like freelance experience will not be considered as it is not a full time job and required number of years of experience cannot be established.
4. Entrepreneurial experience will not be considered for the purpose of ascertaining required number of years of experience.
5. Period of on-the-job training undertaken by the candidates as Management Trainee (MT) / Executive Trainee (ET)/ Graduate Trainee (GT) in only PSUs shall be considered for determining work experience.
6. Articleship / Internship / Academic Project / Teaching / Research experience shall not be considered as Post Qualification Experience.
7. Period of apprenticeship under Apprenticeship Act shall be considered for the purpose of ascertaining required number of years of post-qualification experience.

**6. DOCUMENTARY EVIDENCE FOR WORK EXPERIENCE:**

The candidate is required to submit experience certificate / documentary evidence for establishing work experience as mentioned below;

## 1. For Past Employment -

Candidates must submit work experience certificates for all previous employments mentioned in the application form. These certificates should clearly indicate the date of joining, date of relieving, nature of duties or specific areas of experience, relevance of the experience to the applied post.

In the absence of an experience certificate from any past employer, the corresponding work experience will not be considered. Consequently, if the candidate fails to meet the minimum required post-qualification experience due to such omission, it may lead to rejection of their candidature.

## 2. For Current Employment.

Experience Certificate or Offer letter/Appointment letter / Pay Slip / Identity Card issued by Employer, showing the date of joining and proof of continuity of present employment i.e. Last 03 (three) months Pay Slips from the date of advertisement, which the candidate has mentioned in the application form. In case of non-submission of these documents, it may lead to rejection of the candidature.
